Term of Boarding Contract:

Boarding of _____ shall commence on _____, 20____ and terminate on _____, 20____, if contract is not renewed.

Boarding Payment Fee:

Owner agrees to board _____ at a rate of \$____ / month. Lease fees are due by the **5th of each month**. A \$25 late fee will be charged for payments received after this date. If a boarder is late more than 2 times within the contract period, Driftwood Acres has the right to terminate the boarding agreement.

- Cash, check, Zelle (928-303-3650), or Venmo (sharla-wilson-1) are accepted methods of payment.
 - Returned checks will be charged a \$25 fee.

Boarding Overview:

- ____ 1. Owner is responsible for any excessive damage their horse may cause to stalls or other facility property that is considered beyond normal wear and tear.
- ____ 2. Owner consents to their horse being used for rider lessons at the discretion of Driftwood Acres.
- ____ 3. Owner is fiscally responsible for routinely scheduled equine needs to include farrier, dental, and de-worming that is in addition to monthly boarding fees. You will be notified via text and/or email of scheduled appointment date.

The following is a price chart for such services and are subject to change at the discretion of the service provider.

- Any veterinary care beyond the aforementioned is the owner's responsibility to schedule.
- ____ 9. Horses are to be tied up using the hitching posts outside the barn. No horse should be tacked in the barn, unless given express direction by Sharla.
 - ____ 10. Owners understand the potential risk and injury of horses during equine activities and release all liability from Driftwood Acres.

Care of Horse:

Driftwood Acres shall water and feed boarded horse twice daily to include either pellets or hay not to exceed 20lbs. of feed per day. Owners requesting increased feeding amounts will be charged an additional monthly rate determined by Driftwood Acres. Any additional dietary supplements will be the responsibility of the owner to provide and administer. Driftwood acres, may elect to administer these additional supplements, if they are provided in pre-portioned daily packages at a rate of \$1/day.

Termination of Boarding:

- ____ 1. Driftwood Acres has the right to terminate the boarding lease agreement at any time.
- ____ 2. Boarder must give 60 day notice that they are terminating boarding lease and are responsible for the 60 days (two months) of board at a rate of \$____/month, regardless of whether they remove the horse from facility early.
